Authentication of study documents

1. Diplomas from Moldova do not need any form of authentication. Diplomas issued before 2008 (and diplomas issued after 2008 which cannot be <u>verified on line</u>) shall be accompanied by a <u>Certificate of Authenticity from the Ministry of Education of Moldova</u> which shall be submitted, starting on 01.04.2019, in copy;

2. The <u>Hague Apostille</u> is requested for diplomas from <u>countries which</u> <u>are parties to the Hague Apostille</u>, issued by the <u>competent authorities</u> in the issuing countries. The Hague Apostille is requested for diplomas from Italy, Greece, Spain, Portugal and Cyprus;

3. Diplomas issued in countries which are not parties to the Hague Apostille Convention shall be <u>authenticated</u> or accompanied by an authentication certificate from by the competent authorities in the issuing countries:
